

Minutes of the Annual Parish Assembly held on Monday 14th April 2025.

Prior to the Parish Council meeting the Annual Parish Assembly was held.

The Chairman welcomed everyone to the assembly and said there were to be two talks given. One by Julia Kirby-Smith giving an update on the Save The Blean project and one by Michael Walters on the RSPB.

Save The Blean

Julia gave an update of the position they are at now with communications back and forth with Canterbury City Council. An online petition has attracted 25,000 signatures from all over the UK, the purpose of which was to demonstrate to CCC how people felt. The petition was taken to the CCC cabinet meeting two weeks ago. Following on from this a solution needs to be provided involving partners including Kent Wildlife Trust. STB are in the early stages of developing a plan for the site – working title Blean Bio Park – that includes a country park with a range of fascinating heritage sites, reforestation and rewilding areas, green capital projects that will benefit the whole district, and land set aside for agriculture to protect local food production. They have had workshops and run a survey which has had 124 responses. The group are also having meetings with the University once a month. They are very aware of the financial situation that the University is in and are putting together a proposal to present to the Governing body as an alternative. There will be an update in May from CCC on what the timescales will be.

There followed a Q & A session which included talking about the figures to purchase the land.

RSPB

Michael, although having retired as RSPB Warden in 2012, gave the talk as the present Warden was unavailable. He gave the history starting in 1982 when they started buying land in Church Wood followed in 1989 by getting together with Kent Wildlife Trust, KCC, CCC, Sale Borough Council and the landowner when another large area came up for sale. It was passed over to RSBPB with KWT

having the history of managing woodland. In 2000 Natural England Woodland Trust, who owned Monkey Court, merged with RSPB and it was then all managed as a single Reserve. It extends two miles East to West with three main habitats. Michael then spoke about the coppicing work that is carried out.

Kent is the chief county for nightingales and Blean is famous for heath fritillary butterflies and, although, the white admiral and washed fritillaries had been extinct they have come back in the last few years.

There are two nice areas of heathland, which is extremely rare in Kent, which is managed by livestock. So many species of birds have been lost, in the past forty years we have lost ten species of birds. The woods are getting drier which will affect how the woodland grows. There is a re-wetting project with dams and leaky dams in minor ditches to slow down the flow of water.

There is good news in that there are now buzzards and we may get red kites and ravens. There have been sightings of mandarin ducks although these need large trees with cavities to breed in the woods.

Cllr. Hutt thanked both speakers for their very interesting talks.

Jane Rouse made a plea for volunteers to help with the village fete which is planned for 28th June but may not be able to go ahead if more helpers are not found.

She also mentioned that volunteers are urgently needed for the village hall committee as the Chairman has resigned and the treasurer will be resigning soon.

Planning Applications:

21/00135 - Reserved matters application for the approval of appearance, access,landscaping, layout and scale for the proposed residential development for four detached dwellings pursuant to outline planning permission CA/15/01572/OUT - **Builders Yard Rear Of 53, Tile Kiln Hill.**

Further to Blean Parish Council's last comments of 23/02/21 it would seem that the foul and surface water drainage and archaeology details are still outstanding as no such details have been submitted. These conditions cannot therefore be discharged.

25/00389 - Two-storey detached dwelling - **29 School Lane**.

Blean Parish Council is concerned that the proposed dwelling being less than 1.7m from no 29, will appear cramped and detract from the streetscene on this side of School Lane, with the clear characteristic of spatial gaps between the existing pairs of semi-detached dwellings. As a result, the proposed development immediately adjacent to the Blean Conservation Area will not preserve or enhance its special architectural or historic character or appearance and its setting.

25/00573 - T.P.O. no 26/1990, T1-Ash Tree, Reduce tree by 4m to previous points located in the rear garden - **125 Blean Common Blean Parish Council has no objection to this application.**

25/00586 - Single-storey front, side and rear extensions together with raising the height of the roof following demolition of existing conservatory and front extension to garage - **60 Blean Common - Comments by 2nd May.**

25/00584 - Single-storey side extension with dormers to front elevation following the demolition of existing garage - Hollydene, Pean Hill - Comments by 2nd May.
